- If any payment becomes more than 30 days past due, La Salle, at its option, may declare the entire remaining balance immediately due.
- If this note is placed in the hands of attorney or collection agency for collection, I promise and agree to pay holder's reasonable fees and collection costs even though no suit or action is filed hereon. If a suit or action is filed, the amount of such reasonable fees shall be fixed by the court or courts in which the suit is tried, heard, or decided.
- La Salle reserves the right to deny enrollment and/or disenroll a student whom it determines is unsuitable for enrollment.
- I agree to uphold and comply with the policies and regulations of La Salle, including those promulgated in the Parent/Student Handbook as the same now exists or as hereafter amended, including the Tuition Refund Policy and Student Fundraiser Commitment.
